

- County first circulated a NOP of a Programmatic EIR for the proposed project in 2018
- The project was temporarily paused for additional changes in scope after 2018 NOP was circulated
- County Board of Supervisors authorized a revised project scope in April 2020
- Current NOP was issued to inform agencies and people that the County has resumed preparation of the Programmatic EIR



General Plan Review and Zoning Ordinance Update

Purpose

- The updated General Plan provides the long-term framework for the protection of the County's agricultural, natural, and cultural resources, and for development of the County.
- Expands on and strengthens the major policies of the current General Plan to meet the challenges and needs facing the County through 2040
- The update also includes addressing laws affecting the General Plan, including the addition of an Environmental Justice Element
- The update includes only minimal changes to the land use designations and land use maps in the current General Plan
- The Zoning Ordinance update includes provisions, development standards, and guidelines for consistency with the revised General Plan and State law

General Plan Review Land Use Diagram





- Program EIR broad, comprehensive evaluation to cover many actions, long-range plans
- Many future development projects will require additional environmental review
- Because no specific development projects are proposed, analysis is not parcel specific



- EIR will focus on reasonably foreseeable physical environmental effects that could result from the General Plan Review and Zoning Ordinance Update
- The EIR will screen which land use changes and policies/programs are likely to result in environmental impacts
- Alternatives to the project will be evaluated and considered
