"The work to be done consists, in general, of furnishing and placing screenings over asphaltic emulsion at various existing roads in Fresno County. The seal coat will be constructed on 29.618 miles of roadway on County roads. County forces will repair,

trim, and blade heavy dirt deposits and vegetation from the existing surfacing in advance of construction."

- 3. Submission of Bids/and Bid Bonds & Bid Express Jennica Geddert
 - a. Bid Openings are now conducted over Zoom with bids submitted via Bid Express. Contractors are encouraged to set up their FREE Bid Express accounts in advance. Bids can be saved, withdrawn and updated up until the time of the bid opening so we encourage bidders to try out the software in advance and call or email DesignServices@fresnocountyca.gov if there are any questions about how the bidding software works.
