- The office is open to accept bid bonds and bids so you may also hand deliver your bid.
- The Bid Express and electronic bonding company contact info for their support are posted to the planholders website
- The electronic bid automatically calculates the Award Criteria figure as currency (to the fourth decimal place) but the "\$" will be removed from the final contract
- This year there are additional requirements because of Federal funding for potential work related to the Creek Fire.
- There is no minimum guarantee of work for this contract. There is also a higher maximum value of each contract, compared to previous years.
- Make sure your DIR registration is up to date and paid or your bid will have to be rejected.
- Make sure your bid bond is submitted with the bid or before the bid opening deadline. We will not have a standard practice of asking the Board to waive the requirement to submit the original bid bond before the deadline. Prior allowances were specifically in relation to the COVID-19 state of emergency, which the Board has now lifted for Fresno County.
