#### IV. Honoring March as Women's History Month

Dezie Woods-Jones State President, *Black Women Organized for Political Action. CEO, The Training Institute for Leadership Enrichment (TILE)* 

Dezie Woods-Jones spoke of the inequities across the board including the mental health system, that women have faced throughout history and all the way up to today. African American women are affected more than average women, even though percentagewise they are some of the highest educated groups of people in the nation. While they experience disparities such as under-employment, lower pay rate and higher

expectations, with greater responsibility, it all contributes to their well-being and over all mental health. African American women also have the highest percentage in number of voters, and although that has been recognized, they are still the least represented on boards and commissions and in elected offices from the local level to the national level. Faced with the many differences, it ultimately affects the quality of life. Dezie asked for all to be aware of the inequities and to ask themselves, what efforts are being made in working toward systemic change?

## V. Department of Behavioral Health Update; Director Dawan Utecht

Director Dawan Utecht began her update on the Department by thanking Dezie Wood-Jones for her participation in the meeting and invited anyone interested to participate in a Panel Discussion on Wellness and Holistic Health throughout Her story, on Facebook and/or YouTube Live Friday March 19<sup>th</sup> and Friday March 26<sup>th</sup>. A Flyer will be provided. She also added that March is Social Worker Month, reminding everyone that Social Workers are essential.

#### **COVID-19 Trends**

Fresno is in the red tier for positivity rate and remains in the purple tier for cases per day. In Fresno 267,00 residents have received either the Moderna, Pfizer or Johnson and Johnson vaccine. In detail, slightly under 100,00 residents have received partial vaccination (received 1 dose) and 65,289 have been fully vaccinated. Last week the Department began administering the Johnson and Johnson vaccine to individuals served through a private clinic. Although those individuals are prioritized and eligible to receive the vaccine at any location, they are not guaranteed to receive the Johnson and Johnson as they may at the private clinic.

Data on the impact of COVID on persons served continues to show both adults and children are receiving more services than pre-pandemic. The Department will continue to closely monitor trends and develop plans to ensure the needs of the people served are met while creating a safe in-person environment for them and staff.

# Response to Recommendations to the Board of Supervisors

1. Educate and inform the community about behavioral health services that are available, along with a navigation system for accessing those services.

The Department is in the process of updating their website and is also doing some work on care coordination to work along with other systems of care within the whole system of care.

2. Implement Assisted Outpatient Treatment (AOT or Laura's Law) for individuals who do not respond to existing programs.

The Department intends to continue working toward the required elements of submitting a marketing and education plan by April to the state.

3. Expand housing inventory at all levels of need, including board and care, room and board, permanent supportive housing, and sober living homes.

Many activities occurring with housing through The No Place Like Home grants, Innovation Project of the Lodge, the Master Lease Agreement and the Independent Living Association as well as a couple more projects that are in the pipeline.

4. Establish inpatient Substance Use Disorder (SUD) treatment programs for individuals with Severe Mental Illness.

The Department shares the goal on SUD residential treatment programs and is providing an SUD services report later within this meeting.

5. Implement the Peer Support Specialist Certification Program (Senate Bill No. 803).

The Peer Support Specialist Certification Program is being established by the state and the Department plans to support and conform to the requirements to help individuals become certified.

No Place Like Home (NPLH) agreement with Exodus Recovery for supportive housing services is going to the Board of Supervisors for approval March 23, 2021

Non-competitive allocation is going toward the Avalon Commons project located at Alluvial and Chestnut that will commence with development by the FHA in 2022. 60 units, 6 NPLH tenants, 53 FHA tenants, and 1 property manager.

Tenants will be identified through the Coordinated Entry System and required to meet the HUD or NPLH criteria.

Through an agreement with Community Health improvement Partners (CHIP) and the Independent Living Association, high quality room and board facilities are available promoting independent living in shared housing environment at privately owned and operated homes for adults with disabilities on a fixed income

that would benefit from shared housing. Currently operating 11 homes with 50 beds. Interested persons can visit ilacalifornia.org/fresno-county/

#### Report on Substance Use Disorder Services

Drug Medi-Cal Organized Delivery System (DMC-ODS) began January 2019 covering services that include:

- Outpatient
- Intensive Outpatient
- Narcotic Treatment Program
- Residential (Adult/Youth/Perinatal)
- Withdrawal Management (formerly detoxification)
- Recovery Services (formerly aftercare)
- Case Management
- Medication Assisted Treatment

Overall capacity at all levels of care is a little more now under the DMC-ODS

# Outcomes Report on Blue Sky Wellness Center

Blue Sky Wellness Center provides peer driven education, stigma reduction, social activities with volunteer opportunities and support to address mental illness and/or behavioral health challenges to achieve recovery and wellness. The reporting period from July 1, 2019 – June 30, 2020 \$967,862.49 fully funded by Mental Health Services Act (MHSA) served 712 unique individuals. With the cost per person served at \$1,359 per client. Consumer Perception Survey received an overall satisfaction of 93% of 166 people completing the survey. On March 19th, the Center closed to the public due to the pandemic and the staff at the center began doing outreach telephone calls to individuals in the amount of 3,378 phone calls. The center re-opened on June 15th, 2021. Upon re-opening safety measures taken were screening, cleaning, social distancing and 20-member limit have been implemented. No staff infections of COVID have occurred and no COVID infections of members have been linked to Blue Sky attendance.

One BHB member volunteers at Blue Sky Wellness Center and regularly attends groups and he gave a statement regarding the unity at the center and how all members work together helping each other heal and work toward their individual wellness.

BHB members reported the center having a strong peer driven support system, that in turn helps toward making the program affordable regarding the cost per person receiving the services needed. The staff enjoys being part of the center and in helping individuals receive the many resources they offer.

#### • Report on Substance Use Disorder (SUD) Committee

The committee received a presentation on the new SUD System of Care at the March  $11^{th}$  meeting . The committee will meet quarterly, and the next meeting will be June  $10^{th}$  at 10:00 am. The committee has requested to hear from Westcare, Mental Health Systems and Turning Point on the recovery residences and the services they provide.
