IV. Department of Behavior Health (DBH) update – Dawan Utecht, *Director*

Director, Dawan Utecht began by speaking of the current COVID -19 surge. A very steep curve has occurred in hospitalizations, noting of those hospitalizations a significant number of those individuals are unvaccinated.

B. Report on Culturally and Linguistically Appropriate Services (CLAS)

This is the third year a Cultural Humility Survey was conducted. The use of an outside consultant has helped with the annual report, analysis, and future guidance. As part of the community process there will be stakeholder opportunities for community input and to help guide future.

C. Report on Substance Use Disorders (SUD) Services

Law enforcement reports an influx of Fentanyl into the community as well as there being an increase in overdoses and use of Narcan. Since the spring of 2020 the Department had begun work around Fentanyl. A report that is updated yearly for over a 5- year span on Substance Use Disorders was provided that included data in areas of unique admissions by modality, by age of persons served, ethnicity, race, as well as other data groups in case management, recovery, medicated assisted treatment (MAT) services, telehealth and services rendered in rural areas.

E. Outcomes Report on Youth Psychiatric Health Facility (PHF) Reporting Period July 1. 2019 – June 30, 2020

- Budget \$4,539,981.00
- Actual expenses \$2,596,113

- Unique clients served 469 Fresno County (Total 631)
- Cost per client \$9,839.18

PHF staff are required to gather at least 3 Consumer Perception Surveys every week at random from the youth and caregivers.

Currently there are plans to relocate the PHF facility and expand capacity to 20 beds

- Forensics Committee Next meeting will be October 11th. A provider that is not directly contracted with DBH was asked to present data at the August meeting and was not prepared to provide the requested data. An additional 2 months should provide adequate time to provide the requested data.

- Substance Use Disorder Committee Next meeting is Thursday September 9th and the Committee will hear from Pathways to Recovery program, as well as have a follow-up discussion on Recovery Residence Association (RRA), a program of Community Health Improvement Partners, (CHIP) along with the Independent Living Association (ILA).
- Cultural Humility Committee Last meeting included discussion on receiving more specific information from data collected for the purpose of appropriately providing services for the various components. Training on better defining personal information identified for the LGBQT population was also discussed. The language champion group was approved and presented a couple of goals the group has moving forward. One of groups goals consisted of sharing appropriate terminology to be used with clients. The second goal is to conduct a Bilingual assessment with DBH employees as well as providers that currently receive bilingual pay and wish to continue.
