COVID Update

As of September 14th Fresno County has a hospitalization rate of 377. California has higher hospitalizations due to low vaccination rates, as it proves to be true in all states in the nation. The current surge of the Delta variant has had the highest impact on youth. 1,065,993 vaccinations have been administered which is around 46% of our population.

- Targeted for 9/21/2021 with BOS: Stasis Agreement with Turning Point (Permanent Supportive Housing agreement)

What qualifies an individual for Permanent Supportive Housing (PSH)?

- Required to go through the Coordinated Entry System
- Must be "document ready"
- Assessed/ranked by vulnerability and need
- Must demonstrate the ability to live independently (with support)
- Must have documented Serious Mental Illness (SMI) and/or co-occurring disorder
- If not homeless, but at risk, you may still access housing at a lower ranking of vulnerability

There are protocols in development for additional housing projects that do not require going through the Coordinated Entry System.

d. Outcomes Report on Bay Area Addiction Research and Treatment Programs (BAART)

The Addiction and Research Treatment Program has three clinic locations, in addition to services provided in the Fresno County Jail. The program provides Narcotic (Opioid), methadone and non-methadone medication for treatment of opioid use disorder. The following are all components of the treatment provided:

-Intake- Counseling-Patient Education-Medication Services-Collateral Services-Crisis Intervention Services-Treatment Planning-Medical Psychotherapy-Discharge Services

G. Public Comment

A question was asked to the Department regarding MHSA community planning and if there is any specific topic?

The Department response was that the community planning is part of preparation for the Annual Update. During the Community Planning process, Community Forums are held, providing highlights of the year, brief update information and projections. A period of time is allowed for public comment and a New Annual Update is developed, approved and submitted to the state.

BHB member thanked the Department for opting in with the state on Assisted Outpatient Treatment (AOT) also known as Laura's Law.

BHB Chair noted that the program focuses on the person as a whole and sets goals to aid them in continued recovery. She also mentioned that due to COVID they were down counselors which can make it difficult for the counselors that are present with increased caseloads. Another member mentioned the unique feature of the "Guest Program" utilized by BAART, where inter-agency involvement occurs throughout the state. Lastly the program expressed a goal they would like to reach would be to have better communication with the DBH in the future.
