REQUEST:

Grant a first one-year time extension for Tentative Tract Map No. 5943 and Classified Conditional Use Permit No. 3237, which authorized a Planned Unit Development consisting of the division of a 10.88-acre portion of three parcels totaling 151.32 acres into 58 lots between 2,400 and 3,150 square feet

in size, in the R-2 (c)(m) (Low Density Multiple-Family Residential, 6,600 square-foot minimum parcel, Mountain

Overlay Conditional) Zone District.

LOCATION:

The subject property is located within the Bretz Mountain Village Specific Plan area, on the southeast corner of the intersection of Bretz Road and Garnet Lane (APN's 130-040-

23, 136-374-01, 130-920-17) (Sup. Dist. 5).

## **PLANNING COMMISSION ACTION:**

At its hearing of October 14, 2021, the Commission, as part of its Consent Agenda, considered the Staff Report and determined that the requested one-year time extension was warranted.
