REQUEST:

Allow a religious facility with related improvements on an approximately 1.52-acre portion of a 5.02-acre parcel in the RR (Rural Residential, two-acre minimum parcel size)

Zone District.

LOCATION:

The subject parcel is located on the west side of N. Brawley Avenue approximately 435 feet north of its intersection with W. Olive Avenue and 1,864 feet south of the nearest city limits of the City of Fresno (1501 N. Brawley Avenue, Fresno) (APN 312-112-26) (Sup. Dist. 1).

## **PLANNING COMMISSION ACTION:**

At its hearing of June 10, 2021, the Commission considered the Staff Report and testimony (summarized in Exhibit A).

A motion was made by Commissioner Eubanks and seconded by Commissioner Ede to adopt the Mitigated Negative Declaration prepared for the project, adopt the required Findings of Fact for approval of a Conditional Use Permit, and approve Classified Conditional Use Permit No. 3670, subject to the Conditions listed in Exhibit B. ## Initial Study No. 7705 Conditional Use Permit Application No. 3657

Staff:

The Fresno County Planning Commission considered the Staff Report dated June 10, 2021 and heard a summary presentation by staff.

Applicant:

The Applicant and his representatives concurred with the Staff Report and the recommended Conditions. They described the project and offered the following information to clarify the intended use:

- We bought the property to establish a religious facility; we have been utilizing private residences for religious activities.
- The Fresno area was picked due to its central location in the State; the project location makes it easier for families from Fresno as well as those coming from Los Angeles and Sacramento.
- Economic reasons dictate that the building shall be a metal structure; also, such structure come with an open interior which provides some degree of flexibility in the use of spaces.
- The building is designed to accommodate religious services once or twice a month and includes a kitchen for food preparation.
- The facility will be visited by a maximum of 100 people on Sundays and is provided with an adequate number of onsite parking spaces to meet the need.
- Our service hours are 9 a.m. to 4 p.m. on Sundays only; the services will end at 2 p.m. and by 4 p.m. the site will be vacated.
- A Traffic Impact Study was prepared for the project and was based on the total number of automobile trips in and out of the site twice a month.
- We will have two employees for cleaning and taking care of the facility.

No other individuals presented information in support of or in opposition to the application.

A letter from Fish and Game received after the Staff Report was circulated was provided to the Commission at the beginning of the meeting.
