Grant a one-year time extension to exercise Vesting Tentative Tract Map No. 5430, which authorizes a planned unit development consisting of 275 single-family residential lots, two commercial lots, two lots for future use, and other out lots on approximately 224-acres in the R-1-B(c) (Single-Family Residential, 12,500 square-foot minimum parcel size,

Conditional), R-1(c) (Single-Family Residential, 6,000 square-foot minimum parcel size, Conditional), R-2(c) (Low Density Multiple Family Residential, 6,600 square-foot minimum parcel size), C-M(c) (Commercial and Light Manufacturing), C-1(c) (Neighborhood Shopping Center), R-E(c) (Recreational

District, 2-acre minimum parcel size) Districts.

LOCATION:

The project site is located within the Millerton New Town Specific Plan area, south of Millerton Road between the Brighton Crest Subdivision and the Friant-Kern Canal, approximately 2.5 miles east of the unincorporated community

of Friant (APNs: 300-542-22, 23, 21, 20, 26, 35 and 19) (Sup.

Dist. 5).

PLANNING COMMISSION ACTION:
