REQUEST:

Grant a first one-year time extension to exercise Tentative Tract No. 5415, which authorizes the creation of a 24-lot subdivision with a community water system and a minimum lot size of two acres from five existing parcels totaling 55-acres in the RR- (Rural Residential, two-acre minimum parcel size)

Zone District.

LOCATION:

The subject property is located approximately 500-feet south of E. Shaw Avenue between N. Nelson and N. Academy Avenues approximately 3.5 miles east of the nearest city limits of the City of Clovis (Sup. Dist. 5) (APNs 308-150-05, 18, 20,

37s and 38s).
