REQUEST: Grant the first one-year time extension to exercise Vesting

Tentative Tract Map Tentative Tract Map No. 5430, which authorizes the division of 179.57 acres into 561 residential lots in the R-1(c) (Single Family Residential, 6,000 square-foot minimum parcel size, Conditional) and R-1-C (c) (Single Family Residential, 9,000 square-foot minimum parcel size,

Conditional) Zone Districts.

LOCATION: The subject property is located on the north side of Millerton

Road between Winchell Cove Road and the Friant-Kern Canal, within the Millerton New Town Specific Plan,

approximately 1.8 miles east of the unincorporated community of Friant (SUP. DIST. 5) (APNs: 300-021-27S, 300-032-12S, 300-340-01S, 300-340-03S, 300-340-30S, 300-032-66S).
