### IV. Department of Behavioral Health (DBH) Update

Dawan Utecht, Director

  - Support to continue projects that started under the California Reducing Disparities - Sweet Potato, Hmong Helping Hands and Atencion Plena & Platicas
- b. Report on Foster Care Services
- c. Outcomes Report on Central Valley Regional Center (CVRC)

CVRC helps individuals with developmental disabilities reach their goals. The population served includes children and adults who are substantially impaired due to conditions falling within the legal definitions of "developmental disability". Individuals from Merced, Mariposa, Madera, Fresno, Kings & Tulare counties may be referred by parents, doctors, teachers, relatives, friends, or the individuals themselves. One designated liaison from the Behavioral Health Adult Division and one designated liaison from the Behavioral Health Childrens Division work with CVRC when behavioral health support is needed.

## VI. Public Hearing: Annual Update on Mental Health Services Act (MHSA) Innovations Projects

The Department is approved for 9 Innovations Plans. One plan will go live in December, and one is pending. The other seven active Innovations Plans projects are the following:

- California Reducing Disparities Projects
  - Sweet Potato
  - Hmong Helping Hands
  - o Atención Plena & Pláticas
- Community Planning Process –In yr. 3 of 5
  - o 10 initiatives planned for this year
- The Lodge In yr. 1 of 3
  - o began receiving guests in March 2021
  - o has served 172
- Multi-County Full-Service Partnerships Evaluation In yr. 2 of 3
  - final round of evaluation processes
- Psychiatric Advance Directives- In yr. 3 of 5
  - impacted by COVID-19 and now gaining traction

This update is a hearing update informing the community of progress made on the four Innovations Plan projects mentioned above, which have already been approved by the State and have a set dollar amount for what those plans involve. The set dollar amount is received as a one-time fund for a 3–5-year period. These projects work well as pilot programs and research evaluations, and if used for program development, sustainability must be considered and planned for, should the program prove to be effective.

After providing the update of these Innovations Plans, the final copy will be submitted to the MHSA Oversight and Accountability Commission (OAC.)   - Supplies supports and services indirectly to children and adults with substantial disabilities diagnosed prior to the age of 18 and are expected to continue
  - Clients receive services voluntarily without limitations
  - Clients' family members may sit on their Board of Directors who meet monthly

- Offices in Fresno, Visalia, and Merced
- Currently assist 12,500 clients and 60% being adults with whom they coordinate services for
- Serious lack of Psychiatric help
- o A recent state provision makes services available for 3-5 yr. old children
- o Anticipate the need of more service coordinators and personnel
