#### d. Outcomes Report on Centro la Familia

Centro La Familia provides Consumer & Family Advocacy Services by providing community-based behavioral health support and stigma reduction educational services to all people residing in rural and metropolitan areas of Fresno County who may be experiencing a first break in mental illness or early onset of a crisis. The program also has a subcontract with Fresno Interdenominational Refugee Ministries (FIRM) that

provides similar services to the refugee community

Annual Outcomes Report Reporting Period of July 1, 2019 – June 30, 2020

Actual Amount: \$111,939

• Funded by MHSA CSS

Unique Individuals Served:

• Presentations: 1,964, Outreach: 3,221, Support Groups: 209, Calls: 595, One-on-Ones: 417

Services Rendered:

• Total Program Services: 6,406

Cost Per Person Served

• \$18 per unique client

The program saw an impact on the individuals served from the increased stressors due to the COVID-19 Pandemic. Precautionary measures were taken in response and services continued to provide needed mental health support.

e. <u>Workforce Education and Training (WET) Grant, Office of Statewide Health Planning and Development (OSHPD)</u>

WET Regional Partnership Program Overview-

FY 2019 -20 \$40 Million Appropriated to fund the OSHPD 2020-25 WET 5 Year Plan

- Budget appropriation requires a 33% local match from County Behavioral Health agencies by December 2024
- Upon successful completion of WET Regional Partnership Grant, 5 Regional Partners will be allocated a percentage of funds

Re-invigorate programs to address workforce by:

- Pipeline Development
- Undergraduate College and University Scholarships
- Clinical Master and Doctoral Graduate Education Stipends
- Loan Repayment Program
- Retention Activities

  - BHB member stated that the program has 1 staff member funded through the DBH contract and one-half staff from the FIRM subcontract, which doesn't seem to be enough for the number of services they provide
  - The program stated they have requested to modify the contract so that the program could have the ability to support more staff.
  - The program is currently able to provide services for the robust program by layering services from other additional grants they receive

- b. Review of BHB Public Feedback Survey results
  - 69 responses were received
