REQUEST:

Grant a fourth one-year time extension to exercise Unclassified Conditional Use Permit No. 3275 which

authorizes the operation of a high-intensity park, including an outdoor amphitheater, camping and picnic areas, a shade structure, and launch area for non-motorized watercraft on a 5.93-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre

minimum parcel size) Zone District.

LOCATION:

The project site is located on the west side of Old Friant Road, approximately 930 feet west of its intersection with Friant Road, approximately one and a quarter mile west of the nearest city limits of the City of Fresno (SUP. DIST. 2) (APN

579-020-09).

## PLANNING COMMISSION ACTION:

At its hearing of March 16, 2017, the Commission, as part of its Consent Agenda, considered the Staff Report and determined that the requested one-year time extension was warranted.

Application for such extension must be filed with the Department of Public Works and Planning before the expiration of the Conditional Use Permit.
