All Unit Prices are based on local labor prevailing wages, material and equipment prices and are for the direct cost of construction.

If the 40 aggregate outstanding Job Orders issued under the contract exceeds \$2,000,000, increases in the Payment and Performance Bonds in increments 42 of \$500,000 will be required such that the amount of the Payment and 43 Performance Bonds are not less than one hundred percent (100%) of the 44 outstanding aggregate Job Orders issued. All Work Orders for which a Notice to Proceed is issued by the County Contract Manager during the term of this Contract shall be valid and in effect notwithstanding that the Detailed Scope of Work may be performed, payments may be made, and the guarantee period may continue, after the Contract Term has expired. The bid shall be an increase to (e.g., 1.1000) or decrease to (e.g., 0.9500) the Unit Prices listed in the Construction Task Catalog <sup>®</sup> . Bidders who submit separate Adjustment Factors for separate Unit Prices will be considered non-responsive and their bid will be rejected.
The Owner selected The Gordian Group's (Gordian) Job Order Contracting (JOC) Solution for their JOC program. The Gordian JOC SolutionTM includes Gordian's proprietary JOC Software and JOC Applications, construction cost data, and Construction Task Catalog® which shall be used by the Contractor solely for the purpose of fulfilling its obligations under this Contract, including the preparation and submission of Job Order Proposals, Price Proposals, subcontractor lists, and other requirements specified by the Owner. 26 Pursuant to Section 1773 of the Labor Code, the general prevailing wage rates in the 27 county, or counties, in which the work is to be done have been determined by the 28 Director of the California Department of Industrial Relations. These wages are set 29 forth in the General Prevailing Wage Rates for this contract available from the 30 Department Industrial Relations' Internet California of web site at 31 http://www.dir.ca.gov/DLSR/PWD. Future effective general prevailing wage rates, 32 which have been predetermined and are on file with the California Department of 33 Industrial Relations are referenced but not printed in the general prevailing wage rates.

Addenda to modify the reference to Federal minimum wage 5 rates to reflect revisions thereto, if necessary, will be issued to planholders of record.

7 Attention is directed to the provisions in the "Federal Requirements" section of these 8 specifications. If there is a difference between the minimum wage rates predetermined 9 by the Secretary of Labor and the general prevailing wage rates determined by the 10 Director of the California Department of Industrial Relations for similar classifications 11 of labor, the Contractor and subcontractors shall pay not less than the higher wage 12 rate. The Department will not accept lower State wage rates not specifically included 13 in the Federal minimum wage determinations. This includes "helper" (or other 14 classifications based on hours of experience) or any other classification not appearing 15 in the Federal wage determinations. Where Federal wage determinations do not 16 contain the State wage rate determination otherwise available for use by the 17 Contractor and subcontractors, the Contractor and subcontractors shall pay not less 18 than the Federal minimum wage rate, which most closely approximates the duties of 19 the employees in question.

21 The successful bidder shall furnish a faithful performance bond in the amount of 100

22 percent of the Maximum Contract Value, a payment bond in the amount of 100

23 percent of the Maximum Contract Value, and One Year Warranty Bond in the

24 amount of 10 percent of the Maximum Contract Value. Each bond specified in this

25 Notice (bid bond, faithful performance bond and payment bond) shall meet the

26 requirements of all applicable statutes, including but not limited to those specified in 27 Public Contract Code section 20129 and Civil Code section 3248.

29 Each bond specified in this Notice shall be issued by a surety company designated as 30 an admitted surety insurer in good standing with and authorized to transact business 31 in this state by the California Department of Insurance, and acceptable to the County 32 of Fresno. Bidders are cautioned that representations made by surety companies will 33 be verified with the California Department of Insurance. Additionally, the County of 34 Fresno, in its discretion, when determining the sufficiency of a proposed surety 35 company, may require the surety company to provide additional information supported 36 by documentation. The County generally requires such information and 37 documentation whenever the proposed surety company has either a Best's Key Rating 38 Guide of less than A and a financial size designation of less than VIII. Provided, 39 however, that the County expressly reserves its right to require all information and 40 documentation to which the County is legally entitled from any proposed surety 41 company.

43 Pursuant to Public Contract Code Section 22300, substitution of securities for any 44 moneys withheld by the County of Fresno to ensure performance under the contract 45 shall be permitted.
