REQUEST:

Grant a fourth one-year time extension to exercise Unclassified Conditional Use Permit No. 3291, which authorizes a photovoltaic solar power generation facility with related improvements, including three 1,180 square-foot control center buildings, fourteen 84 square-foot inverter buildings, a 49,500 square-foot substation, and a six-foot-high chain-link fence on an approximately 179.1-acre portion of a 318.18-acre parcel in the AE-20 (Exclusive Agricultural, 20-

acre minimum parcel size) Zone District.

LOCATION:

The project is located on the south side of W. Kamm Avenue approximately 2.51 miles west of the intersection of W. Kamm and S. Lessen Avenues and five miles south of the nearest city limits of the City of San Joaquin (SUP. DIST. 1) (APN 040-

080-15S).

PLANNING COMMISSION ACTION:

At its hearing of December 8, 2016, the Commission, as part of its Consent Agenda, considered the Staff Report and determined that the requested one-year time extension was warranted.
