$\underline{\text{COVID} - 19}$ Trends and Updates

Omicron variant peaked over all for the State in January and Fresno County closely followed. The case rate across the state is now on a downward slope, and Fresno County data is also showing the same. The Department continues to provide in-person services on an individualized basis.

A. General update including Board of Supervisors Agenda (BOS) Items and Legislation

February BOS Agenda Items – <u>Approved</u>

Wellpath- amendment through a grant to add MAT Coordinator Handle with Care- amendment to correct agency name

Will present to the BOS 2-22-2022 Salary Resolution to add three staff positions that will focus on emergency preparedness and disaster planning/response

Legislative Update – AB738 – Would require at least one member of a communitybased Mental Health Board to be a Veteran or Veteran Advocate

> AB1668 – Would require one member be from each of the 10 regions for the 16-member Mental Health Services Oversight and Accountability Commission

B. Outcomes report on the Lodge for 2020 - 2021

The concept for the Lodge was created through part of the MHSA Three Year Plan 2017 – 2020 as an Innovation Plan to explore, identify and understand engagement strategies for individuals that are homeless or at risk of homelessness and are in a pre-contemplative state of change. The plan is to address basic needs with using peer support in a low barrier temporary lodging setting to increase engagement of individuals. The team available for care delivery to assist those individuals consists of 7 Peer Support Specialists, 2 Case Managers and 2 Clinicians. Other support staff are an overnight security, a driver and a janitor, as well as a leadership team of an Executive Director, Program Manager, Clinical Supervisor, Peer Supervisor, Office Manager and Bookkeeper. The following service data provided is for four months of the year with the Lodge being opened for services only since March 1st, 2021, up to the fiscal year closeout.

- Reporting period: Opened for services: March 1, 2020 June 30, 2021
- Budget: \$733,343
- Actual Expenses: \$425,695
- Unique Individuals Served: 190
- Cost per individual : \$2,240.50

Effectiveness

- 16% persons successfully engaged
- 31% reduction Crisis Stabilization Center visits for persons served
- 50% reduction in emergency department utilization

An annual report for the first full year of services will be coming soon.

C. Report on Peer Support Services

Senate Bill 803 defines a peer as someone with self-identified lived experience with the Mental Health or Substance Use Disorder treatment and/or recovery themselves or with a parent/family member receiving services. The bill recognizes peers as critical members of the workforce.

Counties have the option to develop their own plan meeting all statutory requirements or designate an organization to act on behalf of the County and all plans are subject to the Department of Health Care Services approval. After approval from the BOS, the plan for Fresno County is to partner with California Mental Health Services Authority (CalMHSA) to act on its behalf as the designated organization.

The next steps for the Department consist of the following:

- Review and update job specifications to align with the new Peer Certification Program
- Finalize Participation Agreement with CalMHSA
- Prepare for additional changes that will result from the anticipated federal approval of Medi-Cal claiming
