IV. Department of Behavioral Health (DBH) Update Director, Susan Holt

A. <u>General Update</u> - Director, Susan Holt began her Department Update presentation with the monthly suicide data for August 2022 that could be viewed alongside prior years for reference. This data is carefully monitored in partnership with other agencies as part of

the suicide prevention collaborative. The soon approaching month of September is recognized as Suicide Prevention month. There have been some recent updates to the https://fresnocares.org website that includes the rollout of the new suicide prevention lifeline number, 988 as well as information on a multi-county suicide prevention virtual summit happening September 30th, 2022.

C. Department of Behavioral Health Older Adult Team (OAT)Program Review

Since 2007 the DBH OAT provides specialty mental health services to individuals aged 60 years and older who meet the criteria of having a significant impairment due to mental illness. For the reporting period of July 1, 2021 – June 30, 2022, the estimated program expense was \$1,186, 241 and served 602 unique individuals costing an estimated \$1,971 each with 4,125 of claimable services.

While during the 2021- 2022 fiscal year, the program operated at a challenging vacancy rate of 37% the program is allocated for the following positions:

- 6 Clinicians
- 4 Community mental health specialists
- 2 Peer Support Specialists

Services offered;

- Comprehensive assessment and treatment plan
- Individual, family and group psychotherapy
- Case management
- Collateral
- Crisis intervention
- Psychiatric medication services
- Individual and group rehabilitation
