Director Susan Holt began her Department Update presentation with the following acknowledgments for the month of November:

Native American Heritage month

 Veteran's Day November 11th – DBH participation in the Central Valleys Veterans Day parade promoting the theme of "Be There Together" with the 988 Suicide & Crisis Lifeline

Fresno County monthly suicide data:

- October 2022 Five deaths by suicide
- Lower than prior years of 2021, 2020, 2019 & 2018
- Same number as September of 2022
- Additional information was provided as a response to a request from the BHB regarding efforts made by the Department on suicide intervention / prevention strategies specific to the Southeast Asian community
 - No trends or patterns identified to shape a unique strategy
 - Diverse approaches to suicide prevention of audio and visual advertising in different languages
 - o California Reducing Disparities Project (CRDP) Hmong Helping Hands

B. Outcomes and Overview report on the Crisis Intervention Team (CIT)

The Metropolitan Fresno Crisis Intervention Team (CIT) operated by Kings View, provides community-based response to individuals experiencing a behavioral health crisis as well as post-crisis case management and care coordination from 6 AM – 12:00 AM, 365 days a year. Co-located with some members of the Fresno Police Department at the DBH Health and Wellness Center (HaWC). The following information on the program was provided:

- Dates of operation: 12/11/2018 current
- Reporting period: 7/1/21 6/30/22
- Program actual expense: \$2,106,551
- Number of unique individuals served: 3,982
- Cost per individual: \$529

Target goal #1

Increase total number of services provided – 6% increase from the prior fiscal year Target goal #2

Provide linkage and consultation for individuals who are not hospitalized – 100% Target goal

40% of crisis encounters will result in non-hospitalization with safety plan development – 35.46% (still an improvement from FY 20/21 which was 30.88%)

Target goal

Clinician response not to exceed an average of 20 minutes – met with average response time 19.41 minutes

Target goal

80% of stakeholders report a positive score – of 354 responses received 100% reported positive feedback

Crisis care mobile grant agreement was approved on Sept 20, 2022 to expand the program, adding two case managers and some Youth CIT training.

Extension of the Lodge

A Public announcement was made regarding the Department intending to pursue an extension of funding for the Lodge, a Mental Health Services Act (MHSA) Innovations Project. Approved in May 2020 and began serving individuals March 2021. Information regarding the Project and extension below:

- \$4,200,000 for three years
- Project is testing a model for engagement
- Limited time to collect data and analyze and evaluate
- Extension requested to change from 3 yrs. to 5 yrs.
- Included in request is length of stay for individuals from 45 days to 90 days
- A few additional points included in request
