#### A. General Update including DBH Events, Board of Supervisors Agenda Items and Legislation

#### <u>Contracts/Board Agenda Items</u> - Select Items of note

- October 11th Settlement Agreement (45,691) between the Department of Health Care Services and the Department of Behavioral Health for fiscal year 2011-12 Mental Health Services Act Revenue and Expenditure Report Review
  - o Original findings would have been approximately 26 million
  - DBH Finance Team, MHSA Coordinator, and other team members, with support from County Counsel defended and explained how the Department was in compliance and resulted in a fraction of the original amount

#### MHSA Reversion Sustainability Report

Unused MHSA Funds are subject to reversion if unspent or unencumbered.

- \$250,000 in California Housing Finance Agency funds (interest earned)
- Some innovations funds at risk for reversion at the end of the FY and there is a current focus on the Community Planning Process for those funds
- Fresno County does not have any unallocated funds currently

Before the end of the fiscal year any funds at risk will be invested in several plans that are in the works with stakeholders and pending approvals for Innovations (INN) plans that will avoid any risk for reversion.

#### <u>Legislative Updates - Bills of Interest</u>

- AB2317 Assemblymember Ramos
  - Signed by Governor to be effective January 2023
  - Creates new licensing category for which DHCS will create regulations for new licensing category

## On the Horizon – New Electronic Health Record (EHR)

- Board of Supervisors (BOS) approved Fresno County participation agreement in Semi-statewide project
- Goals are to reduce documentation burden and align with CalAIM documentation and payment reform changes
- Increased collective strength of voice with the sate
- Plans to "go-live" next summer

## B. Outcomes report on Local Outreach to Suicide Survivors (LOSS) Team; Hinds Hospice

Inception of program is an outcome from the Suicide prevention collaborative. Funded through MHSA as Part of a Prevention and Early Intervention strategy. The LOSS team Principle is to provide hope through connecting with survivors at the time of loss.

The LOSS Team provides the following activities to survivors of suicide loss:

- \* Active or delayed visits to survivors
- \* Debriefings for survivors, staff and volunteers
- \* Support groups /Bereavement support
- \* Resource packet or package
- \* Individual and couple therapy
- \* Outreach and support to the community

Three of the target goal areas exceeded expectations. In the future the program plans to expand mini sites through networking with organizations already established within the smaller communities.
