NOTICE IS HEREBY GIVEN to the qualified electors of the Fig Garden Fire Protection District in the County of Fresno, California, that on Tuesday, November 5, 2024, there will be submitted to the voters the following measure:

Shall the size of the Board of Directors of the Fig Garden Fire Protection District be expanded from three (3) board members to five (5) board members?

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections office at 2221 Kern St, Fresno, CA 93721, no later than Thursday, August 1, 2024, by 5:00 pm. Paper copies of arguments must be submitted with original signatures, as well as by email to [clerk-elections@fresnocountyca.gov](mailto:clerk-elections@fresnocountyca.gov) in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after Thursday, August 1, 2024, by 5:00 pm.

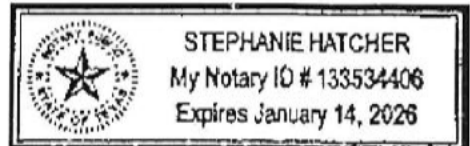
