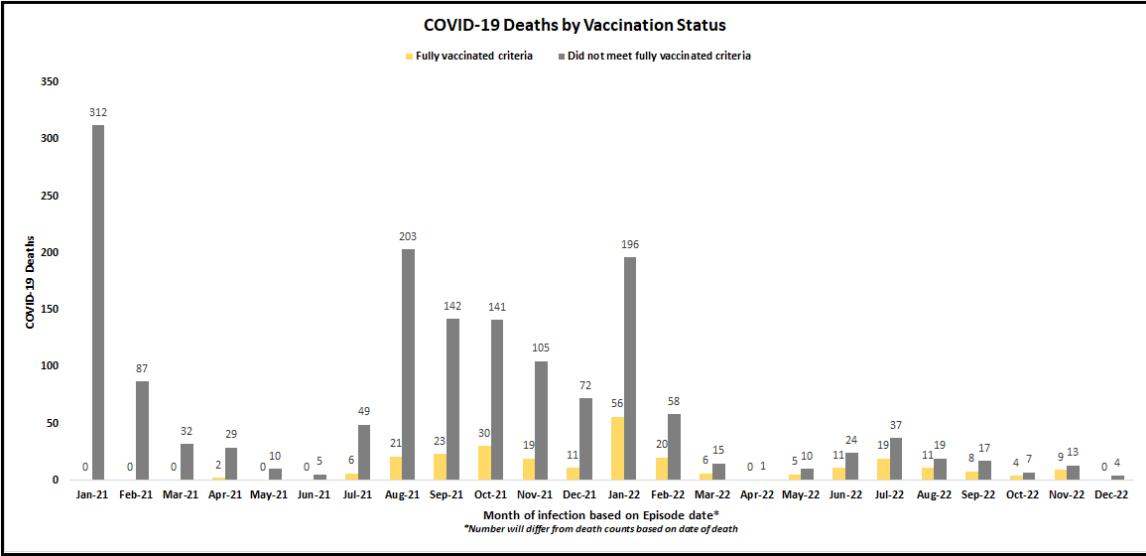
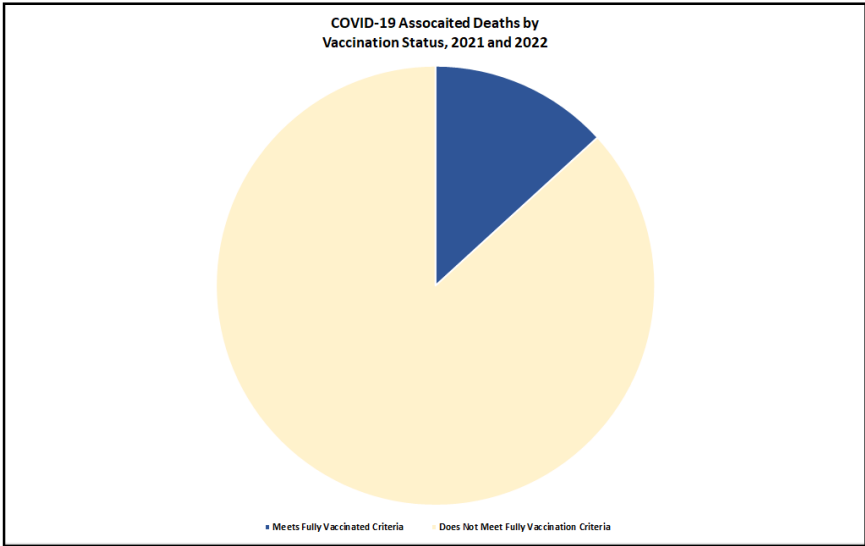
Confirmed Deaths among Fully Vaccinated

Data from CDPH, conducted by matching Immunization records to Case records.

Fully vaccinated (Post-Vaccinated Case):

To be included in this list the following need to be true

- 1 dose in a 1 dose series (J&J) or 2 doses of 2 dose series (Moderna & Pfizer)
- AND
- ≥14 days between final vaccination dose and estimated disease onset date (e. g. episode date)
