## BACKGROUND

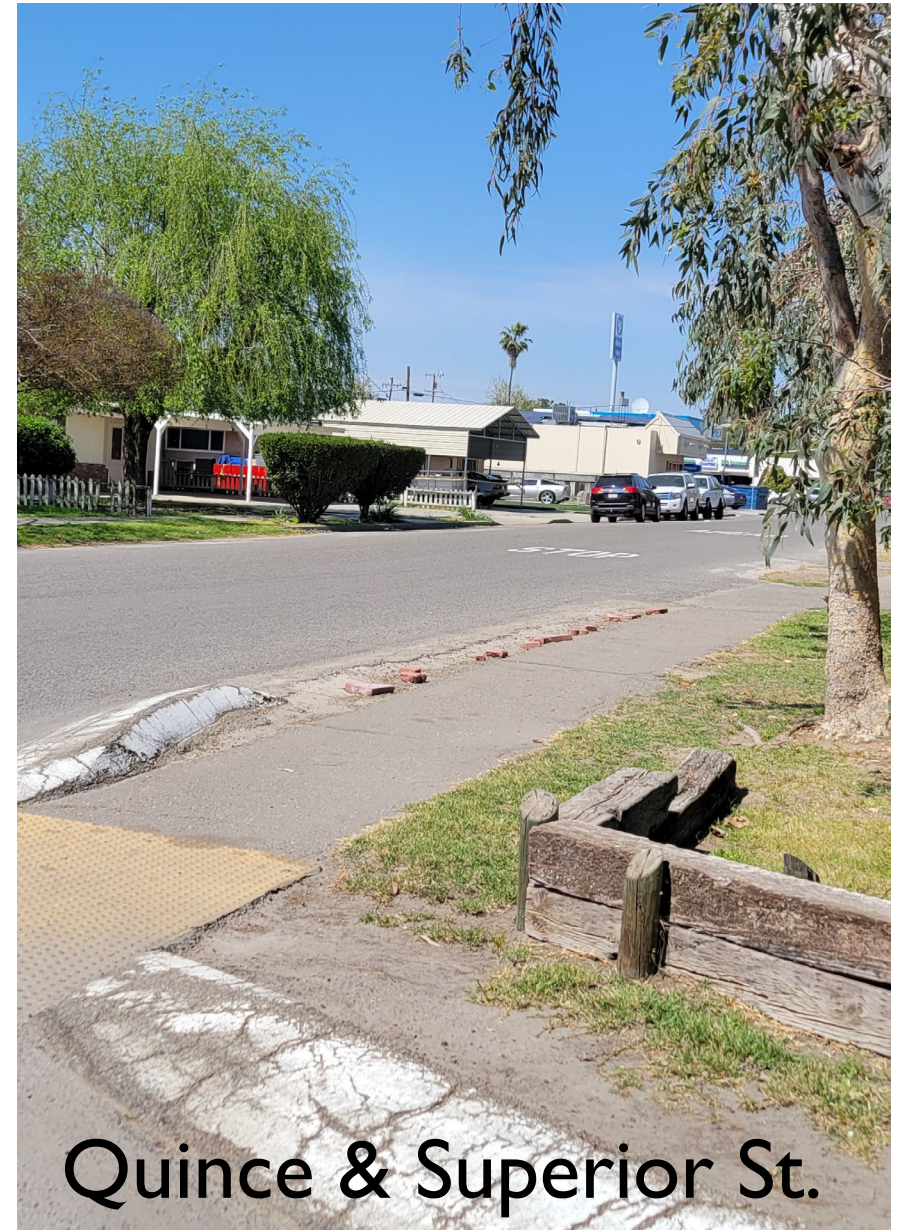
- Most of the community lacks sidewalks and proper drainage making it difficult for pedestrians.
- The purpose of the project is to provide a safe path of travel for all pedestrians separated from vehicle traffic.

## PROPOSED IMPROVEMENTS

- Install new concrete sidewalks. Create continuous path of travel to common areas such as school, parks, etc
- Widen existing roads, add curb, gutter where new sidewalks will be installed.
- Address drainage, eliminate flooding/ponding
- Replace damaged or non-ADA compliant sidewalks.
- Replace existing non-ADA compliant ramps.
- Several trees, other vegetation, encroachments (i.e. fences) alongside the proposed improvements will be removed to allow for sidewalk installation.
- Water meter boxes and other utilities will be adjusted or relocated to clear the path of the proposed sidewalks.

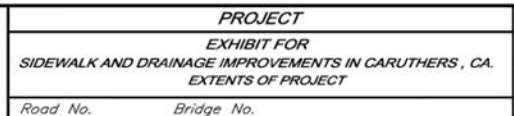

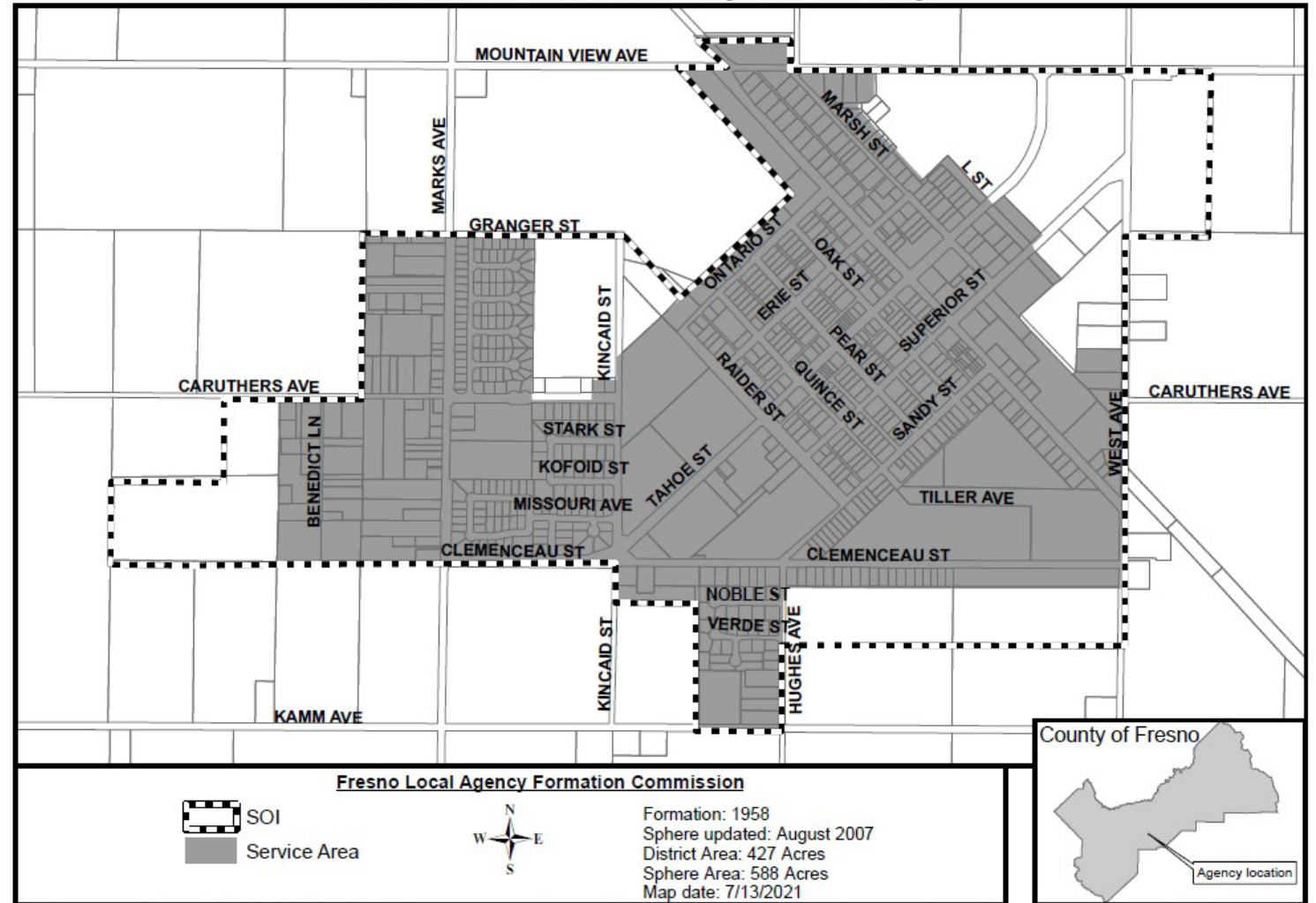
