B. Public Comments/Announcements

When a provider changes their name they need to provide updated copies of their Social Security card and drivers license to the PA. They can leave copies in the drop box at the Clovis Campus Building 1, use the kiosk in Building 1, or they can use the Secure Document Submission link on the PA website.

Hilda from SEIU (guest) asked why call wait times increase while callers are on hold. The PA PM said that the system recalculates wait times based on the length of time callers ahead of that person have been on hold, and sometimes they go up instead of down (for example, if someone has a more complicated question or requires a longer than average call time with PARCC). IT is aware of the issue and are working to determine if the outgoing message can say how many callers are waiting instead of giving confusing wait times. See Director's Report for more information.

Reminder: Joy Moreno is retiring at the end of March. Recruitment for her replacement will most likely begin the following month. There are no other IHSS updates.

<u>IHSS PA</u>

W2s can be downloaded in the ESP portal. The State is in the process of making 2020, 2019, and 2018 W2s available as well.

Direct Deposit will be mandatory as of July 1. Providers and recipients who have not yet signed up are encouraged to do so prior to July 1. They can use either a bank account or a paycard. This is a State process, and the form can be accessed on the ESP portal or the PA website. The State Help Desk phone number is (866) 376-7066.

PARCC is still experiencing an increase in phone calls regarding W2s, the recent Care Economy payment, and the FICO reimbursement (excess taxes taken out that are returned by the State, usually a small dollar amount). There are currently three vacancies in the call center which, along with the unusual payments and inquiries about tax documents has led to longer wait times, though they seem to be shorter than they were last month. This is common this time of year and the PA hopes to fill the vacant positions soon.

PPE is still available for providers and recipients by calling PARCC at 600-6666, or the IHSS SW. Kits will be sent via U.S. mail. SWs also take kits with them on home visits.
