MEASURE TO BE VOTED ON AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE CITY OF HURON TERM OF OFFICE OF MAYOR MEASURE

Notice is hereby given that a special municipal election for the following measure is to be voted on at the Consolidated General Election to be held in the City of Huron on Tuesday, November 5, 2024.

SYNOPSIS OF MEASURE

The City Council of the City of Huron is comprised of an elected mayor and four elected city council members. Each city council member other than the mayor currently is elected to a four-year term. The mayor, currently, is elected to a two-year term.

Measure _ would change the term of the office of the mayor of the City of Huron to a four-year term. The change would have no impact on the staggered dates for elections of the Mayor and all members of the City Council so that in every year ending in an even number, either the Mayor and one other council member or three council members would be up for election. If approved by a majority of the voters the Mayor of the City of Huron would be elected to a four-year term.

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than Monday, August 19, 2024, by 5:00 p.m. Paper copies of arguments must be submitted with original signatures, as well as by email to clerk-elections@fresnocountyca.gov in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body are any individual valor with its fields by legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The Individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after Monday, August 19, 2024, by 5:00 p.m.
